- 🐾 While your pets are boarded they will be handled and treated in a kind and loving manner. They will be properly fed, watered and medicated according to your instructions. Your pet's environment will be cleaned daily and kept properly heated, ventilated as required by weather conditions.*
- 🐾 Your pets will be regularly observed for changes in physical condition. If your pets appear sick or have suffered injury the kennel management has full authority to obtain professional veterinary care at the owner's expense.*
- 🐾 G2D Pet Resort cannot take responsibility for those pets that may get sore feet, hoarseness or soiled coats due to their own hyperactivity.*
- 🐾 Pets that are visually sick or cannot be handled by kennel personnel will not be accepted for boarding.*
- 🐾 Pets considered abandoned will be handled according to Carroll County Animal Control Laws.*
- 🐾 When owners request joint boarding for multiple pets, G2D will not be responsible for injury incurred to pets by each other.*
- 🐾 G2D will not assume responsibility for any liability for pets listed in this agreement of any kind whatsoever, arising out of or from boarding, or any damages which may accrue from any other cause whatsoever, including but not limited to loss by fire, theft, disease, running away, death, injury to persons, animals, or property, or death injury to any other animal caused by the within named pets during the term of this contract.*
